Cedar River Water & Sewer District Commissioner Election

Normally, a water and sewer district commissioner election is a "sleeper election" – no one pays attention to it and usually there are no contested seats. There is a contested (sort of) commissioner position this fall for the Cedar River Water & Sewer District, serving residents and businesses from Fairwood to Hobart down to a northern portion of Maple Valley.

Ronald Harmon and Gregg MacDonald are running for the same position of CRWSD commissioner.

Harmon, incumbent, was chosen to fill last fall's vacant CRWSD commissioner position from a field of three candidates. In a recent interview, Harmon cited his experience in government and long-term planning serving on the City of Kent Council for 2 terms during which time he was on the Budget Committee and Public Works Committee, and chaired the Public Safety Committee, as experience contributing to his qualifications to be a commissioner of CRWSD. He also cites to being appointed to the Washington State Traffic Safety Commission by Governor Jay Inslee and his many years leading teams of people while working as a manager for various companies in the transportation industry. He spent the last year serving as a commissioner for CRWSD during which time he said he learned a great deal about CRWSD, its operations, history, people, customers, objectives, long-term planning, and more.

CRWSD works with consultants to create a 10-year comprehensive plan, last done in 2016 (it runs1279 pages long and consumes 191 MB of data, available for download from the CRWSD website), so an update will be prepared soon. Harmon believes that issues that should be addressed in the next planning cycle include planning for growth within CRWSD boundaries, re-examining its water supply sources, continuing to invest in equipment upgrades and acquisitions that decrease costs and improve worker safety, continuing CRWSD's responsible budgeting, and more. He is proud that CRWSD has a summer internship program from which prospective employees can be hired, has sufficient emergency financial reserves, seeks government grants to supplement customer payments (especially for capital improvement projects) that reduce fees charged to customers and maintain high quality, and has a schedule and plan for replacing wornout equipment. He spoke highly of the people who work for CRWSD.

This is MacDonald's second go 'round attempting to become a commissioner of CRWSD. He ran for the position against current Commissioner Steven Peryear in 2017, garnering only 44.87% of the votes cast. He was contacted by e-mail and phone over the last two weeks and was asked to be interviewed before this article was written. He stated, "I don't think I'm going to win this election. I appreciate your interest." Then, he declined to answer any questions and declined to meet with me.

Jennifer C. Rydberg is a retired attorney, grandmother, and mother of two sons who attended Tahoma schools. She served a term on the Tahoma School District Board of Directors and numerous other local Boards. Active in Scouting America, her husband was a local scoutmaster for 25 years; both received Silver Beaver Awards.

Coast Guard Recapitalizes Command And Control Aircraft

The U.S. Coast Guard executed a planned and critical recapitalization of its long-range command and control aircraft Oct. 17.

These aircraft are required to provide official travel for the secretary of homeland security, deputy secretary homeland security, commandant of the Coast Guard, vice commandant and Atlantic and Pacific commanders as specified by the Office of Management and Budget (OMB) and Department of Homeland Security policy.

"The timing of this investment underscores the Coast Guard's vital need to modernize its command and control capabilities to meet today's rapidly evolving operational demands. As maritime activity increases and national security challenges grow more complex, maintaining reliable air mobility is essential to ensuring continuity of operations and mission success," said Adm. Kevin Lunday, acting commandant.

This purchase replaces planes that were as much as 20 years old and experiencing several unplanned maintenance issues. Since January 2025, U.S. Coast Guard long-range command and control aircraft experienced 30 days of unplanned maintenance, with six missions requiring unplanned cancellation.

"Modernizing the Coast Guard's aging and obsolete aviation fleet is essential to ensuring our ability to successfully conduct national security missions. The purchase of these aircraft will meet our operational requirements for safe, reliable, on-demand military transport with integrated and secure command and control capabilities," said Lunday.

The Service has been operating command and control aircraft for over 65 years, reflecting a long-standing commitment to maintaining airborne command capability as a cornerstone of national maritime safety and security. Robust command and control capabilities, including top secret/secure compartmented information communications, are required for senior leaders to coordinate multi-agency operations across a vast international area of responsibility. The unique command and control capabilities provided by the long-range command and control aircraft enable real-time communication, situational awareness, operational continuity and the ability to direct assets to where they are needed.

In accordance with guidance from the White House and OMB, including OMB Circular A-126, all travel by agency heads qualifies as required use travel. As with the secretaries of state and war, the attorney general and directors of the Federal Bureau of Investigation and Central Intelligence Agency, the White House determined in March 2004 the duties of the secretary of homeland security were such that they require instantaneous secure communications with the White House, the Department of Homeland Security and other agencies. This guidance also determined that in an emergency, the secretary of homeland security must be able to return to Washington, D.C., or proceed to other destinations on an expedited basis.

"It's incredibly disappointing that politicians and the media are playing politics with the funding of the Coast Guard," said Mr. Sean Plankey, senior advisor to the secretary for the Coast Guard. "This is a matter of safety and mission readiness. It's well known that senior military officials and cabinet members need secure command and control and rapid long-range mobility. Flippant comments are great for clicks and fundraising emails, but don't reflect the reality of protecting the American people 24 hours a day, seven days a week and 365 days a year."

President Donald Trump has provided the U.S. Coast Guard unprecedented support through the One Big Beautiful Bill Act to enable the Coast Guard to be the finest maritime fighting force in service to the nation. The Coast Guard remains committed to investing in the most capable and cost-effective equipment for our service men and women. These acquisitions are in line with the policies and requirements for all military combatant commanders, department and service secretaries.



When Coal Was King

South King County bridges remain in the news, after last week's reopening of the Kummer Bridge over the Green River, following a month-long closure, plus the six weeks prior when it was reduced to one lane. The SR-410 White River Bridge shut down on August 18 when it was struck by an over-height vactor truck. WSDOT contractor crews worked seven days a week to repair the extensive damage, and it reopened last Friday, October 17.

Both the Green and White Rivers are of similar length, about 65 miles long from their source to the Auburn valley floor. Historically, the Green and White Rivers joined together in Auburn, then flowed north through Kent and Renton until uniting with the Black River to form the Duwamish, which empties into Seattle's Elliot Bay. For over a decade at the turn of the 20th century, King and Pierce County farmers fought a 'River War,' as neither faction wanted the White River to flood their fields. A November 1906 deluge forced it south, as the two counties continued to battle in court.

The dispute wasn't settled until 1913, when, by judicial decree, the White was permanently diverted into the Stuck and Puyallup Rivers, with the combined flow into Tacoma's Commencement Bay. The course of the Cedar River, which once flowed directly into the Black River, was changed in 1911, after high waters submerged portions of Renton. The next year, Renton dug a 2,000-foot-long, 80-foot-wide canal to reroute the Cedar north, so it flowed directly into Lake Washington. The Black River dried up in 1916, when Lake Washington was lowered nine feet after the Ship Canal, located near Husky Stadium, was opened.

Economic growth in Seattle, Tacoma, and the surrounding towns required that rivers be tamed. Over the 30-year period between 1880 and 1910, Washington State's population grew 15-fold, from 75,000 residents to 1.15 million. Economic growth requires substantial infrastructure, which demands certainty. Wild rivers embody the essence of uncertainty, prompting each region to harness a river's power and mitigate its destructive patterns. Neither the White nor

the Green Rivers were fully controlled until the Mud Mountain Dam subdued the White in 1948, and the Green was brought to heel in 1961 after completion of the Howard Hanson Dam.

Green and White Rivers have similar watersheds measuring about 480 and 494 square miles, respectively. Their water sources differ - the Green is primarily rainfall and snow melt, while the White River is fed mainly by Emmons Glacier with smaller contributions from the Winthrop and Fryingpan glaciers.

The Green flows through 12 miles of steep canyon walls called the Gorge. The White was more prone to destructive flooding due to its broader flood plain. As a result, the Green River is crossed by seven public highway bridges reaching the Auburn valley floor: Kanaskat, Green River Gorge, Kummer, Whitney, Green Valley Road, Auburn-Black Diamond Road, and SR 18. The White River is spanned by only one, the ill-fated, 76-yearold, steel truss bridge that is once again carrying 22,000 vehicles

daily between Buckley and Enumclaw.

The first bridge over the White River is seen in this 1889 photograph of the recently completed Northern Pacific Railway bridge, looking south from Enumclaw towards Buckley. It was taken by W. S. Walbridge of Slaughter. The town was renamed Auburn in February 1893, following an act passed by the state legislature. Walbridge's lower right inscription reads, "White River Bridge and Bridge Crew, Cascade Division. N.P.R.R." Boise Creek can be seen to the left of the
