Black Diamond Community Center recently put out a request for baby diapers. It is the only local agency that stocks diapers for Food Bank clients. Shepherd of the Valley Lutheran Church responded en masse to their request. On Sunday, Nov. 2, the congregation donated 217 diapers, enough to be delivered to both Black Diamond Community Center and Vine Maple Place,

an agency that houses single parents with children.

In addition to diapers, church donations last Sunday included diaper wipes, 28 boxes of cereal, peanut butter, Goldfish crackers, hot apple cider, and syrup. Upon delivery, Vine Maple said they were in dire need of toilet tissue,

and that they currently had no tissue on their shelves. Again, the church stepped up, a member headed to Costco and returned with \$40 worth of toilet issue.

The Care Closet at Vine Maple has an ongoing list of hygiene items. The list includes toothpaste, toothbrushes and

floss, laundry and dishwashing detergents, paper towels, bar soap and liquid hand soap, body lotion, shaving cream and razors, feminine hygiene products, toilet tissue, shampoo and conditioner, deodorant, and unscented tall kitchen trash bags. Hopelink Mobility

On Monday, November 3, 2025, from 7 - 9:30 PM at the Maple Valley Fire Station at 22225 SE 231st St. and via Zoom. Topics discussed were: (1) Hopelink Mobility; (2) Greater Maple Valley/Cedar River Subarea Plan; and (3) Critical Areas Ordinance Update.

Hopelink Mobility

Grace Georgitsis, South King County Mobility Coordinator, for HopeLink, a human-services agency, discussed facilitating access to the community through transportation to make it easier for all people to get around King County. Hopelink resources are offered through the Veterans. Seniors, and Human Services Levy.

HopeLink provides travel education and resources to build awareness of existing transportation options; supports coordination of special needs transportation through cross-sector collaborations; and gathers data and needs to recommend and implement improved services. Hopelink provides one-on-one support with finding transportation options such as local shuttles, volunteer driver programs, medical transportation services, transit, and helps clients navigate public transportation routes and provide suggested trip plans.

Grace also described the Rural Transportation Advocacy Project, which provides tools and resources to help those living in the Rural Area effectively advocate for community transportation so-

Greater Maple Valley/Cedar River Subarea Plan

Kina County Department of Local Services (DLS) Subarea Planning Manager, Susan McLain, discussed progress on the Greater Maple Valley/Cedar River (GMV/CR) Community Service Area (CSA) Subarea Plan. This is a locally specific 20-year plan that covers: Land use and zoning; Housing and human services; Environment; Parks, Open Space, and Cultural Resources; Transportation; Services and

Utilities; and Economic Development.

The Subarea Plan schedule is: Preliminary Plan—January-February 2026; Public Review Draft-June 2026; and Final Draft-December

The Area Council is working to ensure the GMV/CR CSA Subarea Plan work is completed to the community's satisfaction.

Critical Areas Ordinance Update

The King County Council is holding final hearings on the Critical Areas Ordinance (CAO) Update. The Joint Team of King County Rural and Urban Unincorporated Area organizations, coordinated by the Area Council, has been reviewing prior drafts developed by the KC Executive's Office and KC Council Committees.

On October 16 the Joint Team submitted its final Written Comments (http://gmvuac.org/wp/wp-content/uploads/2025/10/CAO-Public-Comments-Joint-Team.pdf) to the KC Council. In general, the CAO Update is very good and offers a greater level of protection to critical areas.

There is extensive use of non-regulatory measures including new and improved mapping, the Land Conservation Initiative, Public Benefit Rating System, and the reduction from 10 ac to five ac for Rural Open Space eligibility, stormwater management, flood management planning. Farm and Forest Management Plans, restoration of damaged critical areas, and other proven strategies. All these measures have multiple benefits, yet provide some flexibility, while still ensuring compliance.

As part of the CAO Update, the "Critical Areas Monitoring and Adaptive Management Program Plan" includes the number of staff, dollars needed, and other things for implementation and do some reforms in the KC Department of Local Services, Permitting Division. To ensure successful implementation, efforts must include assistance to landowners to understand and follow the regulations.

The CAO Update will be finalized/approved by the KC Council at its final hearing on December 2.

Next Area Council Meeting

The next Area Council monthly meeting will be held Monday, December 1, 2025 from 7 - 9:30 PM at the Maple Valley Fire Station at 22225 SE 231st St. (across from the KC Sheriff's Precinct).

Meetings are held on the first Monday of the month (except for Holidays, when they are held on the second Monday). All meeting announcements, agendas, and Zoom information are posted on the Area Council's Website (www.gmvuac.org) and local NextDoor platforms. You can also find us on our FaceBook page (https://www.facebook. com/GMVUAC/). Each meeting begins with an open Public Comment period where anyone can voice concerns, comments, etc.

It serves as an all-volunteer, locally recognized advisory body to King County on behalf of all rural unincorporated area residents living in the Tahoma School District (TSD). I'll do it myself!

"On November 20, 1988, the Los Angeles Times reported: A screaming woman, trapped in a car dangling from a freeway transition road in East Los Angeles, was rescued Saturday morning. A 19-yearold woman apparently fell asleep behind the wheel at about 12:15 AM. The car, which plunged through a guard rail, was left dangling by its left rear wheel. A half dozen passing motorists stopped, grabbed some ropes from one of their vehicles, tied the ropes to the back of the women's car, and hung on until the fire units arrived. A ladder was extended from below to help stabilize the car while firefighters tied the vehicle to tow trucks with cables and chains.

'Every time we would move the car,' said one of the rescuers, 'she'd yell and scream. She was in pain.' It took almost 2 1/2 hours for the passers-by, CHP officers, tow truck drivers, and firefighters—about 25 people in all—to secure the car and pull the woman to safety.

'It was kinda funny,' L.A. County Fire Capt. Ross Marshall recalled later. 'She kept saying, 'I'll do it myself."

As I read this story, it made me think of the response of so many people to the question of where they will spend eternity. Jesus went to the Cross to pay the penalty of sin for the whole world. He took upon himself the sins of the world to justify the righteousness of God and provide forgiveness for sinners like you and me. He did all this, yet the most common response of people when asked how they know they will be in heaven when they die is, "I'm a pretty good person and believe God will accept me into heaven." In other words, they are saying, "I'll do it myself." "If I work hard enough at being good, God will let me into heaven."

Is this really true? If we are good enough, God will let us into heaven? Not according to God's Word, and I'm glad because there is no peace in wondering if you're going to make it to heaven based on you're good behavior. To let you squirm and fret until the end is not a loving God. A loving God provides a way that you can know for sure.

The Bible tells us there is no one who is righteous or good enough to inherit heaven. It says, "all have sinned and fallen short of God's glory" and that "the wages of sin is death, but the free Gift of God is eternal life in Christ Jesus." - Romans 3:23; 6:23. When Coal Was King

For generations, school children were taught, "at the eleventh hour of the eleventh day of the eleventh month - we will remember them." On that day and time in 1918, the Great War came to an end. It wouldn't be known as World War I for another twenty years, when an even greater war eclipsed it.

November 11th was first commemorated as Armistice Day, later known as Remembrance Day, and in the United States, now celebrated as Veterans' Day. It marks the anniversary of the cessation of hostilities on the Western Front after more than four years of battles on the European continent. Many European countries celebrate November 11th as Armistice Day, but throughout the British Commonwealth, it's called Remembrance Day. Armistice Day was approved as a legal holiday by Congress in 1938, and in 1954, an amendment to the law changed the name

The first Armistice Day celebration was held in 1919 at Buckingham Palace. It included a two-minute silence as a mark of respect for the estimated 9 to 11 million military personnel who gave their lives. Millions of others died as a result of disease, accidents, and famine. In Britain, about 2% of the country's population perished. In France, it was 4.4%, in Romania, approximately 8%, and in Serbia, an astounding 17% to 27% were estimated to have died. Mournful songs and poems memorialized the fallen, perhaps none more famous than "In Flanders Fields," written by John McCrae, a Canadian soldier, who succumbed to pneumonia eleven months before the war's end.

On 10/16/2025, officers responded to the 32800 block of SE Cottonwood ST. for a dispute. The officers provided resources and contacted the Mobile Crisis Team to respond and continue providing assistance.

On 10/17/2025 at 0908 hours, Officer's were provided found property after an anonymous citizen located it abandoned at the Black Diamond Cemetery at 24431 Morgan St. Officer's were able to contact the owner by phone and advised the property would be placed into evidence for safekeeping for the time being.

On 10/17/2025 at 1114 hours, Officer's responded to unwanted subjects located near the 30200 block of 224th Avenue SE. The reporting party advised that two subjects over staying their reservation agreement. Officer's later discovered the vehicle one of the subjects were driving, was stolen. The subject was then taken into custody for possession of a stolen vehicle and the vehicle was impounded.



Fighting on the Western Front caused Belgium and France's coal production to plummet. German troops destroyed coal mines in the occupied areas of France and Belgium. Belgium's output dropped to almost nothing by 1918. Extreme labor shortages severely hobbled France's yield, as miners were called up for military service. The scarcity of coal led to higher international prices. Washington State set an all-time coal production record in 1918 of 4.1 million tons, 17% higher than in 1914.

Lloyd George, then British Prime Minister, exclaimed: "Coal is the most important element in the industrial life of this country. The blood which courses through the veins of industry in our country is made of distilled coal." Lloyd George knew coal's importance. Welsh parents raised him, and Welsh, not English, was his first language. Wales was the United Kingdom's primary coal-producing

Even before the first anniversary of Armistice Day, Black Diamond welcomed refugees from Belgium. In late July 1919, the families of Mr. & Mrs. Arthur Beaumet and Mr. & Mrs. Arthur Nicaisse, together with the latter couple's two sons, relocated to Black Diamond. Nicaisse was Arthur Beaumet's son-in-law. During the war, Beaumet's home in Charleroi, one of Belgium's largest cities, was captured by German troops. The Beaumets lost their home and property in the war, so when the fighting ceased, they resolved to begin life anew in America.
